Pembroke County Cricket Club takes the protection of the data we hold about you as a member seriously and are committed to respecting your privacy. This Privacy Notice explains how we may use and protect the personal data we obtain about you and your rights in respect of your personal data.

<b>Automated decisions we may take</b>	The Club will not take any automated decisions about you.
<b>Purposes for which we process personal data</b>	The Club will process the personal data for: <ul style="list-style-type: none"><li>• Administering and Efficient running of the Pembroke County Cricket Club Junior Leagues.</li><li>• Administering bookings and attendance at sessions</li><li>• Supporting the delivery of cricket sessions</li><li>• Training and competition entry</li><li>• Reporting of participation and any incidents and of figures and trends (including equality and inclusion information)</li><li>• Quality and improvement monitoring</li></ul>

<p><b>Who we will disclose your personal data to</b></p> <p><b>[Club to amend to add any additional discloses]</b></p>	<ul style="list-style-type: none"> <li>• Leagues where you have been nominated for / agree to play for a League</li> <li>• The ECB where you are registered for or express an interest in an ECB programme</li> <li>• The County Cricket Board( Cricket Wales) that supports the local Cricket Club whose programmes you have registered for</li> <li>• Coaches and junior co-ordinators for administrating training sessions</li> <li>• Volunteers who work at cricket clubs/venues to support the delivery of sessions.</li> </ul>
<p><b>Legal basis for processing your personal data</b></p>	<p>The legal basis for the collection and processing of your personal data is:</p> <ul style="list-style-type: none"> <li>• <b>for administration and programme delivery:</b> that it is necessary to fulfil the programme that you are going to enter into or have entered into with us</li> <li>• <b>in all other cases:</b> that it is necessary for our legitimate interests which are to build a programme to encourage participation in cricket and does not prejudice or harm rights and freedoms of parents / guardians or the children that join the programme.</li> </ul>
<p><b>Your right to withdraw consent</b></p>	<p>Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time. If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.</p>
<p><b>Location of your personal data</b></p>	<p>The Club will keep your personal data within the United Kingdom</p>
<p><b>How long we will keep your personal data for</b></p>	<p>We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected. We shall retain your personal data for such time as you are registered with Pembroke County Cricket Club as a member.</p> <p>2 years after you cease to be a member of Pembroke County Cricket Club or play an active part in the Club , we shall delete your data excepting that needed to keep historical scorecard and statistical records</p>
<p><b>Your rights in respect of your personal data</b></p>	<p>You have the right of access to your personal data and, in some cases, to require us to restrict, erase or rectify it or to object to our processing it, and the right of data portability.</p>

**You do not have to use the ECB template but if you choose to do so please note the following instructions for making changes**

- The labels in the left-hand column should not be changed
- The text highlighted in Yellow refers to your club name and contact details and needs to be amended to reflect these.
- The information in the right-hand column is that is in blue is seen as applicable in all cases as has been set up in the Play-Cricket system as un-editable
- You may wish to edit or add to other information as you consider appropriate
