## **Ormond Youth Cup and Plate -**

If there are five teams, there will be one group, if there are more than five teams, there will be two groups.

## POINTS SYSTEM:

Four (4) Points for a win; Two (2) Points for a tie. If a side concedes a game, the opponents will be awarded four (4) points. If due to weather a game cannot be completed on an evening, then the game will take place on the next available night, unless both clubs agree otherwise.

Group games can only be re-arranged by the agreement of both sides. If an agreement cannot be reached, the side that is able to play will be awarded the win points for the match, unless under exceptional circumstances, where the Cup Organiser will rule on the outcome.

## ORMOND YOUTH RULES

#### 1. General Rules

The rules of the Harrison-Allen Competition shall apply except for those rules modified by the following paragraphs.

#### 2. International matches

The Executive and Finance Committee of the Pembroke County Cricket Club shall be authorised, on request, to alter the date of an Ormond Youth Cup fixture (excluding the final) should any player from the clubs involved, over the age of fourteen years by September 1st in the year of the competition, be chosen to play for Wales (in an international match or county match), the West of England or any of the other Home Countries.

#### 3. Semi-Final/Final Venues

(a) The Final of this competition will be played on the ground of Carew Cricket Club.

The two scenarios for the semi-finals are:

If there is one group, the winner and runner up will be the home side, if there are two groups, the semi-finals of this competition will be played on the grounds of the group winners.

(b) Should a result not be obtained, or should the final result in a tie, then the match will be awarded to the side scoring the most runs in the first innings. In the event of the match still being tied, the match will be awarded to the team having lost the least number of wickets in the first innings. If the result is still a tie, the match will be awarded to the team which has scored the most runs off the bat in the first innings. If the result is still a tie, then five players from each side will bowl at the wickets.

If the result is still a tie, then a sudden death bowl off will take place.

#### 4. Eligibility

Any player who has reached the age of 18 years by September 1st in the year of the competition shall be ineligible to play.

#### Age qualification:

Players who are selected in the Cricket Wales West Under 12 squad in the spring for a summer squad are eligible to play open age cricket. This is provided they are at least 11 years old and in school year 7 on the 1st September in the year preceding the season.

For those players to play open age cricket, clubs must obtain the written consent of the parents; club safeguarding officer; and the Pathway Lead (Cricket Wales West) on the appropriate form.

In allowing these players to play in open age cricket, it is essential that clubs and coaches recognise the duty of care obligations they have towards these young players.

Players who are not in a Cricket Wales under 12 squad must wait until they reach the U13 age group. i.e. 12 years. Should any club field an under age player then that club may be liable to a fine not exceeding £50 and will lose all points awarded in that match.

#### 5. Clubs Combining

a. All players taking part in competition shall be bona-fide playing members of their respective Clubs. Clubs, however, may combine, but permission to do so must be obtained in writing from the Executive Committee before the First Round Draw has been made. No more than 2 clubs may combine. Combined sides cannot use permit players'

b. Where a Club does not enter a team in the Ormond Youth Cup, a bona-fide member of such a club, as defined by League rule 6b) (page 65), may play for a club entered in the Ormond Youth Cup, on completing and signing an Ormond Youth Cup registration form. Form to be completed before the start of play on that day and returned to the Cup Organiser along with the official team sheet. (a date of birth must be certified by the players parent or guardian). A maximum of three players from other clubs can play at any one time for the host club.

The onus of proving a player is a bona-fide Ormond Youth Cup playing member, rests with the Club concerned.

#### 6. Match length/Bowling restrictions

Each match shall consist of twenty (20) overs for each innings. No bowler may bowl more than four (4) overs in an innings. The Final Round shall consist of two (2) innings, each of twenty (20) overs, for each side. The final of the Ormond Youth Plate shall consist of one (1) innings of twenty (20) overs, for each side.

#### 7. Tied matches in final or semi-final

In the event of a tie in the Ormond Youth Cup semi-final and the Ormond Youth Plate final, an additional over will be bowled with a new toss. Normal fielding restrictions will be played, (No power play), and the bowler must be nominated and the batting order given to the umpires. If the match is still a tie, additional overs shall be bowled until a result has been obtained.

#### 8. Tied matches in group stages

Should two sides have the same number of points on completion of the group stages, the outcome will be decided on the results between the two sides during the group stage. If there is still a tie, then the number of wickets taken in group stages will decide.

#### 9. Umpires

Expenses of £15 per Umpire will be shared by the participating Clubs.
